- Give the names and phone numbers of two personal references (not OYC members)
- Attach a copy of proof of boat ownership if applying as flag member

• Present the initiation fee with the application. All current fees, Initiation and dues, will be explained by the membership Chairperson. Initiation fees are not refundable after the Board of Directors has accepted the new member.

Our Membership Committee evaluates membership applications and makes recommendations to the Board for approval or denial of membership. The Committee will schedule applicants for personal interview and orientation during the 45-day waiting period between application and potential acceptance into membership. The application and the Committee's recommendations are presented to the Board for action at a subsequent monthly meeting (second Thursday of month). When application/membership is approved, you will be invoiced for that full month.
